# Request for Proposals Launched for Two New Provincial Integrated Youth Services Hubs

September 23, 2024 (St. John's, NL) – Choices for Youth (CFY), Newfoundland and Labrador (NL) Health Services, and the Government of Newfoundland and Labrador are pleased to announce the launch of a Request for Proposals (RFP) for two new Integrated Youth Services hubs in rural and remote parts of the province. This initiative marks a significant milestone in the implementation of a provincial Integrated Youth Services (IYS) model, by scaling from one hub in St. John's to three connected IYS hubs across the province. IYS is an international best practice, with over 100 IYS sites operational across the country, and 50 additional sites in development.

After five years of extensive community engagement and developmental work, paired with building from the successful model within CFY's existing IYS Hub, CFY and NL Health Services are thrilled to advance with the establishment of a provincial model of mental health and wraparound support services for youth and young families in Newfoundland and Labrador. This model has been shaped by the input of eight steering committees and over 65 community partners since 2019, with invaluable support from philanthropic contributors.

The investment will establish two new initial IYS hubs in rural and remote parts of the province. These hubs will provide a comprehensive range of services including mental health support, housing, food security, primary care, public health, and family and natural supports. This initiative aims to provide low-barrier mental health and social services and ensure that youth and young families receive the support they need closer to home.

CFY has operated an award-winning IYS hub since 2004, known as their Outreach and Youth Engagement Centre. In collaboration with partners such as NL Health Services, CFY manages an integrated hub that provides comprehensive mental health, primary care, housing, and other wrap-around social services support to youth in a single location. Serving approximately 1,300 young people each year, CFY is excited about scaling this successful model to additional regions across the province through partnerships with community agencies and NL Health Services.

The RFP process will enable eligible groups to apply for the opportunity to operate these new IYS sites, adhering to national best practices and standards.
